3 IT IS HEREBY ORDERED that the notice of motion and motion for assignment of rights,
4 turnover order, and restraining order be and the same is hereby granted.

5 IT IS FURTHER ORDERED that all accounts, accounts receivable, rights to payment of
6 money, contract rights, rights to payment of money from third parties, contingent rights, deposits
7 and deposit accounts, claims against third parties, monies due from third parties, due and in favor

26 from third parties, the subject matter of the assignment hereunder.

27 IT IS FURTHER ORDERED that Defendant SHENG HSIANG JEN FOODS COMPANY,
