3 IT IS FURTHER ORDERED that all accounts, accounts receivable, rights to payment of
4 money, contract rights, rights to payment of money from third parties, contingent rights, deposits
5 and deposit accounts, claims against third parties, monies due from third parties, due and in favor
6 of and for the benefit of Defendants, or any of Defendants' family members, business associates,
7 partners, assignees, and other persons acting on his behalf, due Defendants OLD CITY HALL
8 LLC, a limited liability company dba OLD CITY HALL, and DANIEL PAUL BARDUZZI, an

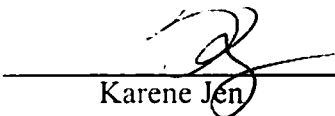
