2 restraining order is hereby granted.

3 IT IS FURTHER ORDERED that all accounts, accounts receivable, rights to payment of
4 money, contract rights, rights to payment of money from third parties, contingent rights, deposits
5 and deposit accounts, claims against third parties, monies due from third parties, due and in favor
6 of and for the benefit of Defendants, or any of Defendants' family members, business associates,
7 partners, assignees, and other persons acting on his behalf, due Defendants RAM SERVICES,
8 INC., a corporation dba RAMSEY'S FIREHOUSE DELI & PUB, and RONDY M. SCIPPIO, an
9 individual, are hereby assigned to Plaintiff US FOODSERVICE, INC., care of its attorney, David

20 prohibited, stayed and enjoined, from the assignment, mortgage, lien, or sale of any of the
21 accounts, accounts receivable, rights to payment of money, and claims for payment of money due
22 from third parties, the subject matter of the assignment hereunder.

23 IT IS FURTHER ORDERED that Defendants RAM SERVICES, INC., a corporation dba
24 RAMSEY'S FIREHOUSE DELI & PUB, and RONDY M. SCIPPIO, an individual, shall deliver
25 all checks, cash, notes, instruments, deposits, deposit accounts, checks, drafts or warrants, to the
26 San Joaquin County Sheriff, 7000 Michael Canlis Blvd., French Camp, CA 95231.

1 IT IS FURTHER ORDERED that Defendants RAM SERVICES, INC., a corporation dba
2 RAMSEY'S FIREHOUSE DELI & PUB, and RONDY M. SCIPPPIO, an individual, appear on a
3 weekly basis, before the below court, to testify as to the condition of all of the accounts and
4 accounts receivable, notes, instruments, checks, warrants, deposits, and other rights to payment of
5 money and evidence thereof, and to periodically hand over and deliver to the Clerk of the Court,
6 for the benefit of Plaintiffs, any and all documentary evidence of any of the accounts herein,
7 including checks, drafts, money orders, accounts and deposit accounts, pursuant to C.C.P. §
8 708.110(a) and C.C.P. § 708.250.
